- a. Meeting was held June 10, 2020.
- b. Games to start September 19th – 8 games, 8 weekends. No blackout dates. No rescheduled games. Off for Columbus Day. Exception made for tournaments - teams will be given off for tournaments and will be allowed to double up on a weekend to get their scheduled game in.
- c. EPYSA has released new guidance. Practices can now start with 25 players per field, but no contact for 2 weeks. After 2 weeks, scrimmages can start.
- d. No ref fees for York USA yet. Cost will be passed along when EPYSA releases ref fees.
- e. York USA will not charge a fee if a team must cancel a game because the team has come down with COVID-19.
- ii. CPYSL (Tim Scripko)
 - a. Club has a \$100 fine for not attending enough meetings in 2019.
 - b. Meeting is scheduled for June 17, 2020. Tim Scripko will send out information after the meeting.
- d. Registrar (Will Lasher filled in for Heather Roe)
 - i. We have 84 players registered for the Fall season so far. There are 94 partially registered.
 - ii. Registration has been extended to June 19, 2020.
- e. Field report/Equipment
 - i. Equipment is locked up. Bleachers and goals are off of the fields. Fields are being maintained by the township.

 - vi. Work on developing an operating budget.
 - vii. Fall Spirit Store: Emily talked to Brandon at 2 The Tee. Spirit Store will need to open July 12th and close by August 2nd to have items back in time for the start of the season.
